The Bylaws have been reviewed by Legal and changes have been notated in red. The changes in yellow are from the Bylaws committee. Due to the number of changes, the Bylaws will not be up for approval tonight.

- **Ad hoc Committee**
  - Consider approval of the Bylaws at the next meeting.
  - Would like "House Rules" to be given to CMC members (as adopted by Council).
- **Communication, Learning, Understanding & Education (CLUE)**
  - Consider partnering with Hope Clinic, Carter Blood Care, and Helping Hands. The Global Youth Conference has not had further discussion. The committee will have a recommendation at the next CMC meeting as to which project to work on.
- **Community Services**
  - Committee will open dialog with various community services in regards to how we can partner with them. The focus is diversity and engagement as well as being strategic.
  - Marcie has started a database for the Restaurant Guide and suggested everyone will need to contribute to it. Finding restaurants in their own districts would be a great place to start.
- **Multicultural Affairs**
  - Mosaic Festival was suggested to be held on the downtown square in October; two dates were available in October. CMC would consider partnering with GDBA (Garland Downtown Business Association), the Hispanic Chamber of Commerce, and the downtown businesses. Motion made by Marcie; seconded by Deo to have the Mosaic Festival on the downtown square; motion passed. The date will be decided later. CMC will consider asking to have Sixth Street Crossing blocked at the railroad tracks (near the apartments and library) to help with foot traffic and to allow traffic around the square to continue as normal.
