# Water Conservation Credit Program Guidelines for High Efficiency Washing Machine

## Program Guidelines:

- Participant must reside at or own the property where the qualifying item is to be installed and their City of Garland utility account must be in good standing. This program is for residents only; commercial requests will not be eligible.
- The program limits a once in a lifetime washing machine conservation credit per family residing in Garland at any address. Credit for the purchase and installation of a new high efficiency washing machine is based on a three tier compensation table relating to the level of efficiency. A credit of \$125 is given for washing machine models in Tier 3, \$100 for Tier 2 and \$75 for Tier 1. For a list of qualifying machines visit the Consortium for Energy Efficiency website at [www.cee1.org](http://www.cee1.org). Look under the "CEE Program Resources" tab. **NOTE: If your new washer is not on the list and all other requirements/application are met, you will still receive a conservation credit in the amount of \$50.**
- Applications must be received within 120 days of purchase of eligible water conserving item. Credit applications will be processed in the order they are received on a first-come first-serve basis. All credits are subject to the availability of funds. The funding for this program is limited and granted on an annual basis. Please check our website at [www.GarlandWater.com](http://www.GarlandWater.com) under the "Conservation" tab to ensure funds are available. **Funding for each fiscal year will run between October 1 through September 30.**
- The City of Garland does not require a plumbing permit to install a new washing machine. No participant shall receive more than a \$500 credit from the City of Garland's Water Conservation Program(s) for any combination of eligible items.
- Old washing machines that are replaced MUST be disposed of in a proper manner.

## Water Conservation Credit Program Application Instructions:

- Select, purchase and install a high efficiency washing machine from the qualifying list. A link to this list is available at [www.GarlandWater.com](http://www.GarlandWater.com) under the "Conservation" tab.
- Mail in the water conservation credit application along with a **copy** of the sales receipt or invoice and a **copy** of the front cover of the Owners' Manual.
- Originals of all copies must be retained and available for review should an onsite verification occur.
